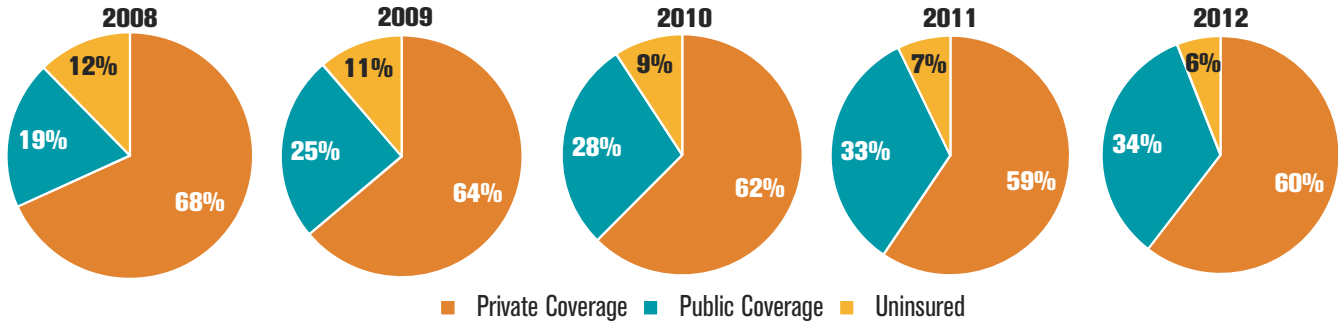


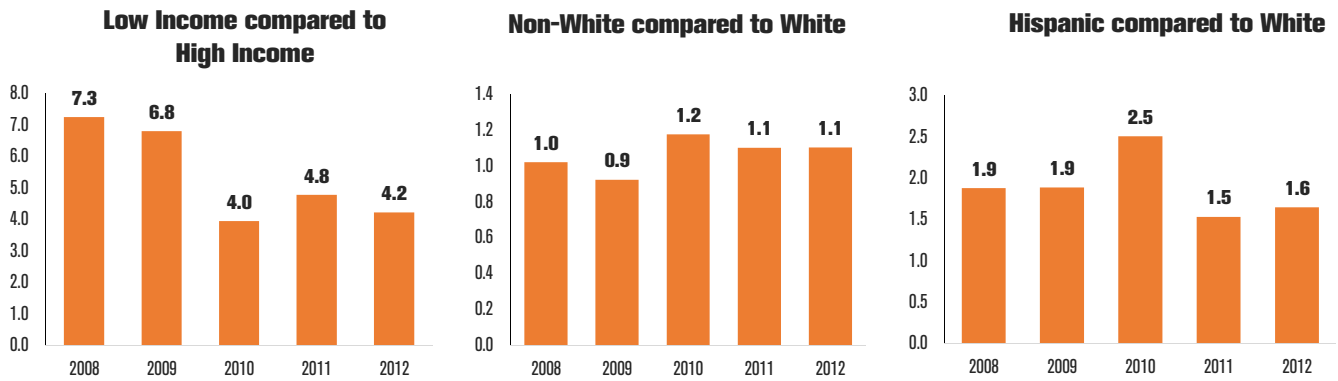

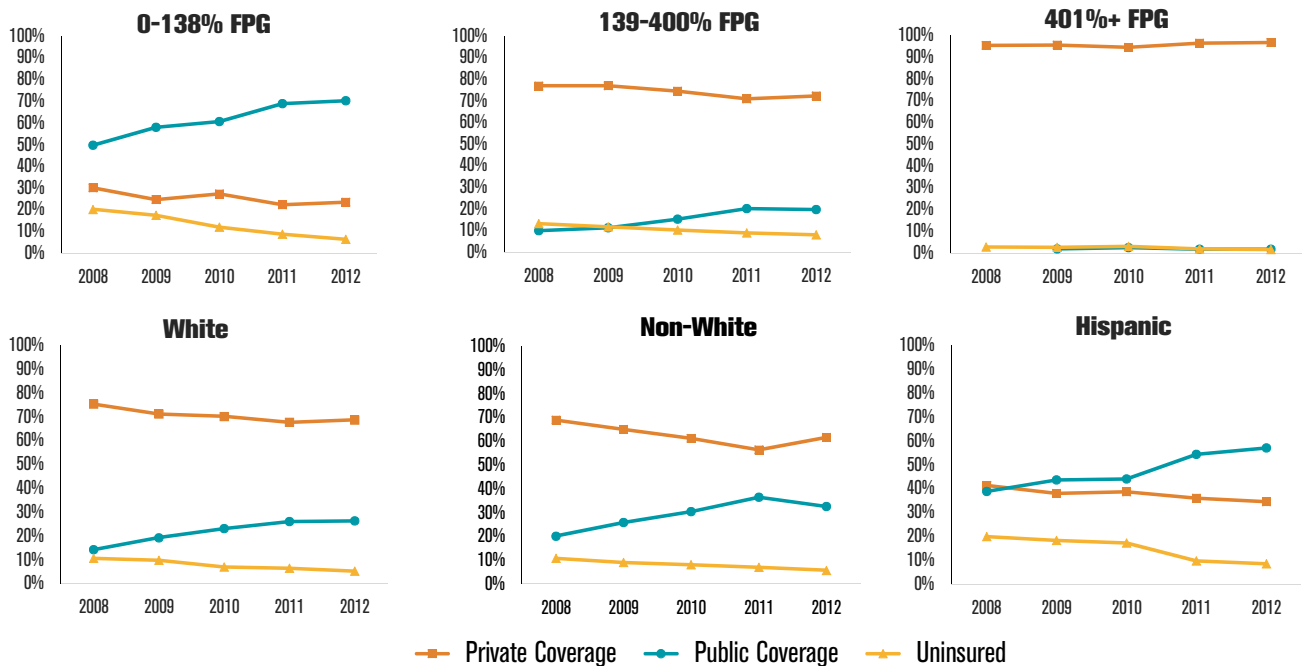
Sources of Insurance Coverage
