SHAP Benchmark Reporting

- Comparable enrollment data and information about lessons learned
- Used to demonstrate success of SHAP and provide lessons for implementation of Affordable Care Act (ACA)
- Collected bi-annually in concurrence with HRSA reporting
- Round 1 successfully collected in July, 2010 – Thank you!
- Round 2 will focus on very similar information and will be collected in February, 2011

Significant Changes from Previous Benchmark Collection

- New enrollment AND Current/Point-in-time enrollment
 - Total ever enrolled through 2/28/2011
 - Current enrollment on 2/28/2011
- Information about disenrollment
- SHAP program position relative to state's ACA implementation
- Grantees will have more lead time and more time to report
- Timing should allow you to use this information in your HRSA reporting
